If Agent is prevented from furnishing the music, or any other elements thereof, because of acts of God, strikes, illness or other causes beyond Agent’s control, Agent shall not be in breach, and may substitute talent, subject to your reasonable approval. Failing said approval, this agreement shall terminate without obligation of either party to the other, except that Agent shall return to the Purchaser the sum paid upon execution hereof. Any cancellation on the part of the Purchaser will result in forfeiture of deposit.

11. If within 13 months of the conclusion of the engagement herein, should the Artist(s) be re-engaged by the Purchaser, both Purchaser and Artist(s) agree that the contract will be negotiated by Dizzy Lizard Productions
